**FULL PLANNING APPLICATION FOR THE RELOCATION AND ERECTION OF A
TEMPORARY VIEWING PLATFORM, KINGS CROSS CENTRAL, LONDON N1C
4AH**

On behalf of King's Cross Central General Partner Limited (KCCGPL), please find enclosed an application for full planning permission for the relocation and erection of a temporary Viewing Platform, for a period of up to 18 months, on land within the King's Cross Central development site. Accordingly, we enclose a cheque for £385.00, being the requisite planning fee, along with the following:

- signed and dated application forms; and
- Submission Statement (with Design & Access statement) dated January 2014.

The platform is currently in situ at the south western corner of the junction between Goods Way and the King's Boulevard. It was originally granted planning permission on 3rd May 2013, reference 2013/1260/P, for a temporary period of 8 months, in connection with the display of an art installation by Felice Varini, 'Across the Buildings', a part of the art programme RELAY at King's Cross Central, reference 2013/1375/L.

We wish to retain the Viewing Platform at the site for an extended temporary period in a new location. 'Across the Buildings' has been removed from Granary Square, however, the Viewing Platform continues to be a valuable and popular asset to the site for tourists and visitors in its own right.

The development of the northern end of Development Zone B necessitates a change in location of the platform, to an adjacent site at the south eastern corner of the junction between Goods Way and the King's Boulevard.

The enclosed *Submission Statement* describes the proposals and contains the relevant documentation and information to support the application including: the Design and Access Statement; an appraisal of the proposal's compliance with relevant planning
