Oak Tree came down in the recent winds. It damaged the Ash Tree 1 ( bent ) and potentially dangerous to neighbours conservatory so needs pollarding. Sycamore Tree ( half crown) due to Oak falling has made the sycamore Tree dangerous as leaning towards back of 37 Ferncroft Av, London NW3 so needs 35-40% reduction to make it safe. Multi - Stemmed Ash is also dangerous and tilting towards neighboiurs gardens so again needs 35-40% reduction to make it safe.
