We Advise: - Trim back as much overhang as possible to boundary line.

G2: CLEMATIS - Detach Wisteria that is tangled into the Clematis at the edge of the building allowing the remainder to die off in due course.

T3: BAY - Been worked on by us in the last few years but client still feels it is too big in both height and width

We Advise: - Reduce in height by 6ft. Trim sides to create a more narrow shape.

T4: LARGE CONIFER - Trim back to clear garden pathways.

G5: MIXED HEDGE - Lightly trim the top down to create a neater looking hedge.
