Remove the tagged various shrub groups (ID 5) located at the entire property.

Prune Apple 9(ID 2) located at the rear garden right boundary according to the following specifications:
Clean, thin and reduce crown as necessary to promote fruit production and quality. Fruit tree pruning will reduce the risk of branch failure due to excessive fruit production.

Prune London Plant (ID 4) located at the neighbours garden (Finchley Road) according to the following specifications:
Reduce x 3 lowest branches by approximately 3-4 metres to provide clearance to garden.

Prune Bay Tree (ID 3) located at the neighbours garden (no 6) according to the following specifications:
Reduce crown spread by approximately 2-3 metres to provide clearance to garden.
