T1 Hornbeam (located at the right rear of the property): reduce crown height and spread by approximately 1-2 metres to provide clearance to gardens. Thin crown to remove approximately 10% to live branches to improve light and air penetration through crown. Most thinning cuts will be between 2 and 3 centimetres in diameter.  
T2 Magnolia (located at the front of the property): thin crown to remove approximately 10% of live branches to provide branch definition. Most thinning cuts will be between 2 and 3 centimetres in diameter. Reduce crown height and spread by approximately 0.5 to 1 metres to provide clearance to house.  
T3 Magnolia (located at the front of the property): reduce crown height by approximately 0.5 to 1 metre to renovate overgrown shrubs.  
T4 declining Hawthorne and Cherry (located at the front of the property): dismantle, leaving stump as close to ground as possible.
