Sorry for the late reply. The design of the proposed house still needs to be improved. It is still too elaborate. The Council's design officers preferred the design concept of the refused scheme (ref: 2012/2920/P). I recommend you should use the similar style of doors and windows detailed in the refused scheme and reduce the height and bulk of the proposed house to prevent harm to the amenities of the neighbouring properties. The low level openings which would serve the basement level on their own are considered to be acceptable.
