Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).



2 The development hereby permitted shall be carried out in accordance with the following approved plans: Site location plan; 322.060 Rev - B; 322.061 Rev - B; 322.062 Rev - A; 322.004 Rev A; 322.005 Rev B; 322.001 Rev A.

Reason: For the avoidance of doubt and in the interest of proper planning.

3 An Acer campestre 'Elsrijk' or an Amelanchier arborea 'Robin Hill' shall be planted as a heavy standard, single stem tree with a girth of 12-14cms, in the location identified on plan 322.060 rev B. The tree shall be planted in the first planting season (November - March) following completion of the works in line with the recommendations of BS4043:1989 and shall be suitably staked and tied. Should the tree die within 5 years of planting it shall be replaced with a tree of the same specification.

Reason: To ensure that the development achieves a high quality of landscaping which contributes to the visual amenity and character of the area, in accordance with the requirements of policies CS14 and CS15 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.
