Site Description

Nos. 16 - 25 comprises a Grade II listed terrace of 10 houses dating from the mid-C19; stucco-fronted in Italianate style. No. 26 adjacent is a terraced house dating from the early C19, also listed Grade II. The buildings are in educational use, and some have been laterally linked.

Assessment

Listed building consent and advertisement consent is sought for the installation of wayfinding signage to the buildings' exteriors, all at the rear lower ground level. The buildings are in educational use, and are occupied by various different UCL departments. The main access for staff and students is at the rear elevations of the buildings.

There are existing plaque signs which are not providing adequate wayfinding, so it is proposed to install projecting signs, for clarity. The existing ad hoc and out of date signage will be removed and replaced with consistent signage.

The projecting signs will measure 440mm x 600mm. One projecting sign will be affixed to the rear elevation of each closet wing. In addition, there will be a departmental sign measuring 650mm x 260mm located on the rear wall of each building, below cill level, adjacent to the entrance doors. Finally, three map signs are proposed, which measure 600mm x 800mm.

None of the signage will be illuminated.

Listed building consent:

The proposed signs will be screw fixed in to the wall, into the mortar joints, to avoid damage to facing brickwork. They will be finished in black, with a stone colour trim. Their position, low down on the rear elevations, method of fixing and finish are not considered to cause harm to the special interest of the buildings. The principle of the signage is considered acceptable given the buildings' use. All existing redundant signage will be removed, so the new signage will not create visual clutter.

Advertisement consent:

The Town and Country Planning (Control of Advertisements) Regulations 2007 permits the Council to only consider amenity and public safety matters in determining advertisement consent applications.

Amenity: the proposed signs do not obscure any significant architectural features, and are considered

to be acceptable in terms of proportions and design.
It is not considered that the sign would be unduly obtrusive in the street scene or disturb residents or occupiers.
Public Safety: the location of the signage is not considered harmful to either pedestrian or vehicle traffic. The proposal therefore raises no public safety concerns.
Recommendation:
The proposed signage complies with the relevant local and national policies and guidance. The applications are therefore recommended for approval.
