


Proposed new rectangular section steel balustrade to new roof-level terrace. Finish to be painted, RAL 9017 Traffic Black

Existing balustrade to neighbouring roof

Existing adjacent mansard roof extension

Proposed mansard roof extension set back from existing entablature, profile and roof pitch to match adjacent. Finish to be natural slate to match existing and adjacent roofs.

Proposed new lead clad dormer construction with double glazed timber sliding sash windows with glazing bar profiles and proportions to match existing windows below. Timber fascia trim to front face of dormer painted white.



Elevation to Rear

Proposed new rectangular section steel balustrade to new roof-level terrace. Finish to be painted, RAL 9017 Traffic Black

Proposed new opening roof light to provide access to new roof terrace (shown partially open)

Proposed new closed roof light over stairwell

Proposed mansard roof extension set back from existing facade line, profile and roof pitch to match adjacent. Finish to be natural slate to match existing and adjacent roofs.

Proposed new lead clad dormer construction with double glazed timber sliding sash windows with glazing bar profiles and proportions to match existing sash windows below. Timber fascia trim to front face of dormer painted white.

Existing valley profile to rear elevation to be retained.
