The existing rear extensions have been an integral part of 31 Percy Street for at least a decade. This is supported by the statutory declaration attached to this application. It is estimated that the mid-floor cantilevered extension between first and second floor level was built within the 1950s - 1960s due to its condition, the building construction method and the materials used.
