The site is a large landmark building in style of 19thC coaching inn at the brow of the hill near Whitestone Pond; listed Grade 2, built in 1962 and designed by Raymond Erith; located in Hampstead Conservation Area and adjoining Hampstead Heath. Assessment

Proposal

The proposal seeks the installation of a painted timber roof level safety guardrail and copper flashing laid around the roof terrace cornice in order to weather proof this and repairs to the existing timber where it is rotten.

<u>Amendments</u>

Officers have requested a section of the copper flashing to ensure it overlaps the edge of the cornice and prevent water ingress into the cornice causing further damage.

Design

Guardrails

The proposed guardrails are located on the north eastern corner of the roof of the property. The proposal seeks to fit two 50mm square timber rails fitted between the chimney stack and the crenulated tower in the north eastern corner of the roof. This will provide safer access for maintenance to the roof.

Due to the size of the building the location of the guardrails will be relatively discreet and would only be seen from glimpsed views from North End Way or Heath brow to the north. The timber material finished in paint is also acceptable.

Copper flashing

Copper flashing is proposed to be located along the existing timber cornice on the edge of the terrace at the north western corner of the building at 3rd floor level. The existing cornice is plywood and is in a poor state of repair. This will be repaired and the copper flashing added to further protect this from the weather. The proposal has been designed to slightly overlap the edge of the cornice which means water would run off and over the edge and not down in through the exposed edge.

Both proposals are considered acceptable as they do not cause harm the special architectural or historic interest of the property, or the character and appearance of the Hampstead Conservation Area and therefore are considered compliant with policies DP24 and DP25 of the LDF 2010.

Amenity

No amenity issues are created by the proposals. Compliant with policy DP26.
