Tree in front garden of 141 Prince of Wales Road. Subject to TPO and is known to the council. Plan provided.

The Horse Chestnut tree in the front garden of 141 Prince of Wales Road previously (in 1997-1999) caused significant damage to 139 and 141 Prince of Wales Road. The insurance companies of both residences require tree to be pollarded and crown reduced regularly. Please could you provide consent for a crown reduction to previous pruning points. The works will be completed by a qualified and recognised tree surgeon.
