Thin crown to remove approximately 20% of live branches to reduce crown density. Most thinning cuts will be between 3 and 4 centimetres in diameter.

Reduce upper crown spread by approximately 2-3 metres to provide clearance to garden.

Prune Plum (ID 2) located at the rear left boundary according to the following specifications:

Reduce crown spread by approximately 2-3 metres to provide clearance to garden.

Prune Lime x 5 (ID 3) located at the rear right boundary according to the following specifications:

Reduce crown spread by approximately 2-3 metres to provide clearance to garden.
