- All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.
  - Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 if in CA of the London Borough of Camden Local Development Framework Development Policies.
- The development hereby permitted shall be carried out in accordance with the following approved plans OS map, Design, access and heritage statement, Basement Impact Assessment (provided by Cooper Associates dated April 2013), 1209/EE-001, 1209/EE-002, 1209/EP-001, 1209/EP-002, 1209/EP-003, 1209/EP-004, 1209/EP-005, 1209/ES-001, 1209/AE-001, 1209/AE-002A (dated 14/06/13), 1209/AP-001A (dated 14/06/13), 1209/AP-004, 1209/AP-005, 1209/AS-001A (dated 14/06/13).

Reason: For the avoidance of doubt and in the interest of proper planning.

The roof of the rear extension hereby permitted shall not be used as an amenity roof terrace without prior consent in writing from the Local Planning Authority.

Reason: In order to prevent unreasonable overlooking of neighbouring premises in accordance with the requirements of policy CS5 of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 of the London Borough of Camden Local Development Framework Development Policies.
