The Council has considered your application and decided to **refuse** listed building consent for the following reason(s):

Reason(s) for Refusal

The proposed first floor side extension, by reason of its siting, height and bulk, would unbalance the symmetry of the principle façade and the historic floor plan, causing



harm to the special architectural and historic interest of the listed building, contrary to policy CS14 Promoting high quality places and conserving our heritage of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 Conserving Camden's heritage of the London Borough of Camden Local Development Framework Development Policies.

The proposed insertion of a door at first floor level, by virtue of its siting, position and loss of historic fabric, would result in harm to the special architectural and historic interest of the listed building contrary to policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy; and policy DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.
