This application is a resubmission of a withdrawn application (ref 2012/6582/P) made within the past 12 months. The application had been withdrawn on the advice of the planning officer Mr Fowler, who advised that the scheme needed to be made bigger for a favourable outcome. We had been advised that he would provide pre-app advice to assist a resubmission on the condition that we withdraw the application. Following the withdrawal, we had consulted several times with Mr Fowler including meeting with him at the planning department. The result of this consultation ended with Mr Fowler requesting that the scheme be significantly reduced in size, significantly smaller than the original scheme. The advice given by Mr Fowler had removed our opportunity to appeal any decision on the first submission. Overall, it has been (in our opinion) poorly conducted and very misleading. As a result of the delays incurred by Mr Fowlers conduct, a complaint is due to be issued to the council.
