### **TOWN & COUNTRY PLANNING ACT 1990 (AS AMENDED) NATIONAL PLANNING POLICY FRAMEWORK 2012**

**Hampstead Parochial Primary School Holly Bush Vale London NW3 6TX**  
*Erection of single storey extension, canopies and decking to existing school (D1).*

#### **Recommend No Archaeological Requirement**

Thank you for the consultation dated 22nd April regarding the archaeological potential of this site in the context of the proposed development. Having considered the proposals it is concluded that there is no archaeological interest due to the small-scale of the groundworks.

I do note that there is a slight risk that post-medieval burials will be encountered as a map of 1879 can be interpreted as showing the adjacent burial ground running into the western edge of the site. However this appears to be a cartographic error as ordnance survey maps of both 1868 and 1893 show the boundary between the burial ground and school in its present location. I therefore simply recommend that an informative is added to any consent advising that should human remains be unexpectedly encountered then the requirements of burial law must be adhered to.

Please do not hesitate to contact me should you require any further information. This response relates solely to archaeological considerations. If necessary my Inspector of Historic Buildings and Areas colleagues should be consulted separately regarding statutory matters or Borough Conservation Officer as appropriate.




