The part of the building to be demolished is a brick extension at the rear lower ground and ground floor, that was built approximately 10-15 years ago.

Why is it necessary to demolish or extend (as applicable) all or part of the building(s) and or structure(s)?

The current rear kitchen extension is unsympathetic in terms of its construction and materials, especially the roof and windows.

The new extension will use London stock brick and timber fenestration to fit in with the historic character of the existing property, and will provide the property with more efficient and generous living spaces at lower ground and ground floor levels.
