Prune London Plane (T600 (ID 23) located at the main drive next to security hut according to the following specifications:  
clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.  
Thin crown to remove approximately 20% of live branches to reduce risk of root failure. Most thinning cuts will be between 3 and 4 centimetres in diameter.  
Prune London Plant (635) (ID 22) located at the Grays Inn Fields according to the following specifications:  
Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.  
Reduce crown height by approximately 7-7.5 metres to reduce risk of root failure.  
Reduce crown spread by approximately 2-2.5 metres to reduce risk of root failure.  
Small suppressed tree on main drive to be removed as discussed.
