
1926 41 CT Drainage Plan




1920 42 CT Basement, Ground and First Floor Drainage Plan






1932 42 CT Basement Drainage Plan





Sirs,

I regret to inform you that a fire took place on these premises on the morning of Saturday, 13th June.

The outbreak occurred in the dressingroom on the 2nd floor, and while this room was almost completely gutted and the furniture destroyed, fortunately beyond that from smoke, there was no damage to the remainder of the building.

The principal credit for this is due to the Euston Fire Brigade, which came very promptly and handled the fire in the most expeditious and efficient way, and their quiet demeanour helped to restore the confidence of the inmates, who were naturally very much alarmed.

The Fire Risk on the house is covered by the Gresham Fire & Accident Insurance, and the fire damage has been agreed at £83.10. -. and accepted by the Insurance Company, and the repairs will take place in due course.
