1 In the absence of mechanical ventilation information the applicant has failed to demonstrate that the proposed units would not be adequately protected from noise from external sources, contrary to policy CS5 (Managing the impact of growth and



development) of the London Borough of Camden Local Development Framework Core Strategy and policies DP26 (Managing the impact of development on occupiers and neighbours) and DP28 (noise and vibration) of the London Borough of Camden Local Development Framework Development Policies.

Informative(s):

1 Reason for refusal of condition 16 could be overcome by providing details of mechanical ventilation in compliance with Inspectors prescribed levels.
