Renewal of planning permission dated 19/04/2010 (ref 2010/0368/P) for alterations to pitched roof of extension, as an amendment to planning permission dated 30 July 2008 (ref. 2007/5761/P) for the erection of single-storey rear ground floor level extension and addition of a pitched roof with 13 rooflights to the flat roof of the existing dwellinghouse. The development hereby permitted must be begun not later than the end of three years from the date of this permission.



Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 [and DP25 if in CA] of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans: Site Location plan; AVTL/009/001A; 001B; 002A.

Reason:

For the avoidance of doubt and in the interest of proper planning.

Informative(s):

- Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974.
