- 1) 2 x Lime's - Crown reduce by up to 3.0mt, remove deadwood and reshape to leave a natural outline. Also, reduce the overhang as far back as possible from the patio, whilst retaining a natural shape and flow to the crown.

7. Identification Of Tree(s) And Description Of Works continued ...

- 2) 3 x Sycamore's - Reduce overlong branches overhanging the gardens by 4-5mt. Crown raise over the neighbours house to clear by 3.00mt. Thin by 20% and cut a swathe through the Ivy @ 7.0mt. to kill it and remove all greenery leaving a network of stems attached to the tree, these are hard to remove and if removed at this stage will damage the tree. ☐
- 3) Conifer - Lightly trim back the overhang by 1.0-1.5mt.
- 4) Rear garden of 69, Hawthorn - Crown reduce by 2.0mt. and reduce the overhang from no. 71 by 2.0mt.
