Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

All new work and work of making good shall be carried out to match the original work as closely as possible in materials and detailed execution.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans: 1229 P 01; 1229 P 02 1229 P 03; Alexandra and Ainsworth Estate Planning Application ref 20122 2683 Camera Locations; dedicated micros 2060 precision surveillance dome specification; Infiniti PTZ specification.

Reason: For the avoidance of doubt and in the interest of proper planning.
