#### Proposal:

Alterations to existing property to include demolition of existing outbuilding and extension to lower ground floor at side and rear with terrace at ground floor level and external access stair from ground floor to garden. Replacement of existing fenestration to front, rear and side elevations to all floors. Removal of existing 2 rear dormer windows and replacement with 1 dormer window with sunken roof terrace.

## Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three



years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans EX-01, EX-02, EX-03, EX-04, EX-05, EX-06, EX-07, EX-08, PL-001A, PL-002A, PL-101A, PL-102, PL-103A, PL-201A, PL-202, PL-203A, PL-204A, GA.2.05A, PL-301A, PL-302A, PL-401A, PL-501A.

#### Reason:

For the avoidance of doubt and in the interest of proper planning.

The rooflight on the rear roofslope shall be a conservation type rooflight (flush with the slope of the roof).

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

# 3 Reasons for granting permission.
