THE ORIGINAL APPROVED WINDOW TYPE DID NOT PROVIDE A SAFE METHOD FOR CLEANING THE GLASS. AN UPGRADED WINDOW TYPE IS PROPOSED TO REVERT TO SIDE HUNG CASEMENTS TO THE FRONT AND REAR. A STRONGER FRAME IS REQUIRED FOR THE SIDE HUNG CASEMENT UNITS. THIS IS ALSO MORE IN KEEPING WITH THE EXISTING WINDOW CONFIGURATIONS.

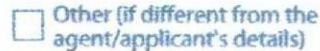
