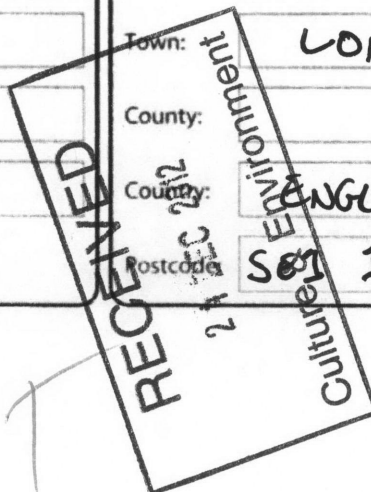

All 3 Sycamore trees have been observed by Camden tree officer Tom Little on 22/11/12 who agreed with the condition of trees and proposed works.

**T1 Sycamore** This tree has an extensive cavity at the main fork. The cavity extends into both stems of the fork. A fruiting body was found, but its condition was too poor to be positive of identification, although I suspect *Polyporus squamosus*. The extent of the cavity vs. remaining sound wood and its position at the main fork all indicate that remedial work is required. Given the canopy of the tree and not least the height until first branch break (i.e. previously branches have been removed to a high height), it is my opinion that any remedial works sufficient to reduce the likelihood of failure would significantly disfigure the tree and/or reduce the vitality to such an extent as to further its demise.

*Works specification: dismantle and fell to near ground level.*

**T2 Sycamore**

*Crown reduce by approx. 1.5 – 2m (15% of foliage)*

**T3 Sycamore**

*Reduce by approx. 15%. Selective crown reduction. Remove ivy down to main fork, and trim back remaining ivy growth, also remove epicormic.*
