## THE BRITISH MUSEUM - PLANNING APPLICATION SUBMITTED UNDER THE TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED) 2012/4638/P

Further to the submission and registration of this planning application and our subsequent discussions, it has become necessary to add an additional element to the application, namely:

The formation of a widened entrance within the external elevation of the King Edward Building with glazed panel doors within the internal façade and for the construction of a glazed link allowing an additional access point from the Bells Landing to the extension to the Museum (approved under reference 2009/4638/P).

Listed Building Consent has also been applied for and is being considered by your colleagues. I have accordingly amended the description of the Listed Building Consent application to reflect this and ensured that the additional plans prepared by Rogers Stirk Harbour and Partners have been submitted to accompany the application.

The additional element is described at item v and the description is in bold type:

- i. An additional glazed exit from the Special Exhibition
- ii. An additional requirement for a Building Management Unit (BMU) mounted on the roof of pavilions 2, 3 and 4
- iii. Revised locations and increased height of the flue stacks associated with the flume extract systems in the Conservation and Scientific Research
- Additional requirements for air exhaust trumpets at Level 00 and 02
- v. The formation of a widened entrance with glazed panel doors within the external elevation of the King Edward Building and the construction of a glazed link to provide access to the special exhibition space.
