Please find enclosed the samples for the stone pavements on Pancras Square and Pancras Road. The development at Pancras Square level does not occupies the full extent of the site boundary for Plot B1. The upper levels do extend to it, cantilevering over the ground floor levels.

The proposed exterior pavements on those areas, as indicated on the plans, are a seamless continuation of the pavements on the square and the footpath respectively.

Proposed pavement stone for Pancras Square: Yorkstone-Cromwell Diamond Sawn Finish.

Proposed pavement stone: Yorkstone-Scoutmoor Diamond Sawn Finish.

We hope that this satisfies your requirements for these outstanding Planning Conditions. I have also enclosed some technical data of each type of stone.
