1	London Plane	<i>(Platanus x hispanica)</i>	Located within the boundary of William Goodenough College, this is a large tall mature tree overhanging & encroaching on roof, guttering & west elevation of the building & cutting out light: In order to contain spread, clear the building by 2-3m more, pre-empt potential damage to roof, gutters etc & to improve light: Reduce & re-shape crown by 25-30% all round, retain crown continuity. Thin & clean out crown, remove deadwood, weak & suppressed branches & suckers. Lift canopy by 2-3m all round & balance.

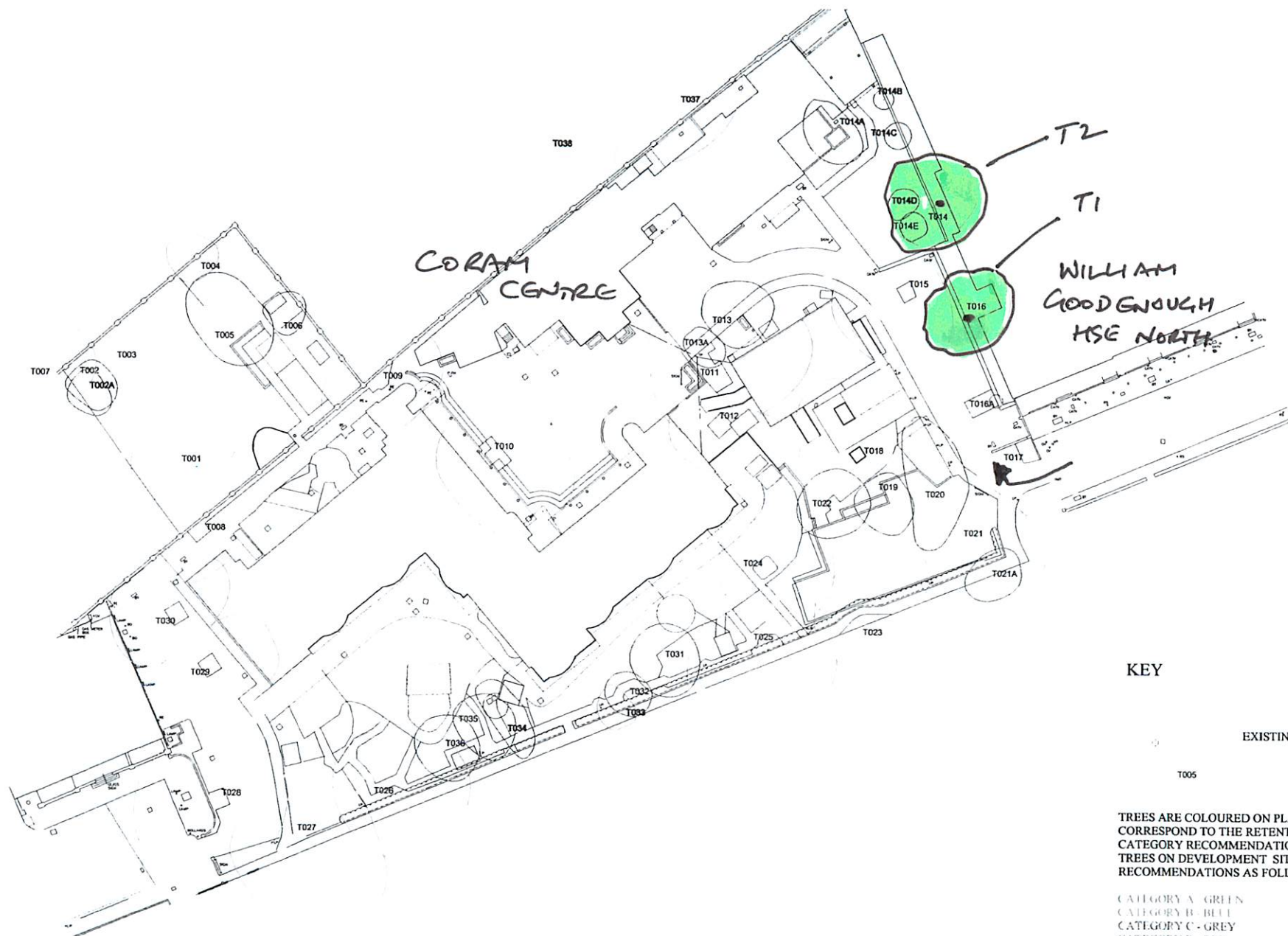
