## CONSERVATION AREA ENFORCEMENT NOTICE.

OF 19 Chester Road London N19 5DE

1. **THIS IS A FORMAL NOTICE**, which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 74(1) of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

#### 2. THE BUILDING.

## Land at: 19 Chester Road, London N19 5DE

as shown for the purposes of identification only, outlined in black on the attached plan.

#### 3. THE CONTRAVENTION ALLEGED.

Without conservation area consent: The unauthorised demolition of the front garden boundary walls

#### 4. REASONS FOR ISSUING THIS NOTICE

The work outlined above has been carried out to this building without the benefit of Conservation Area Consent.

a) The unauthorised demolition of the wall is detrimental to the character and appearance of the host building, street scene and wider conservation area contrary to policies CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy, and policies DP24 (Securing high quality design), and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

## 5. WHAT YOU ARE REQUIRED TO DO

The notice shall require that within a period of 3 calendar months of the notice taking effect the front garden boundary walls be re-instated to match the height, location and design of the walls shown on existing plans refs 04 and 05 of planning permission 2012/1479/P.

# 6. WHEN THIS NOTICE TAKES EFFECT.

This notice takes effect on 9 January 2013 unless an appeal is made against it beforehand.
