T16 - Syacmore - Remove lower branches to lift by 2m and thin by 10-15%; reduce away from building by 2m approx

T17 - Hazel & Elder - Trim/lightly reduce to contain

T19 - Ash - Fell to ground level as deep truncal wound and decay
