Front Garden - Right Hand Side  
T3 - Young Magnolia  
Reduce height to approximately 8 feet from ground level and shape accordingly.  
Front Garden - Right Hand Side of Garage  
T4 - Magnolia  
Reduce height to approximately 14 feet from ground level and shape accordingly. Remove Creeper from the tree.  
Front Garden - Right Hand Side of Garage  
T5 - Creeper Clad Malus  
Reduce Creeper from the tree. Reduce height to approximately 14 feet from level and shape accordingly.  
Front Garden - Left Hand Side of Garage  
T6 - Yew  
Reduce height to previous reduction points, retaining healthy growth and shape accordingly. Reduce back to clear adjacent building.  
Reasons - (T2 to T6) - Part of a maintenance programme to reduce the trees to a more desirable and suitable size for their locations. To allow more light into the property. To enhance the aesthetics of the trees.
