1) Replacement of Crittall metal windows

Full Planning Permission Granted – Ref – 2011/1830/P
Listed Building Consent Granted – Ref – 2011/1829/L

2) Replacement of window with door and new guard cage around down pipe

Full Planning Permission Granted – Ref – 2011/4638/P
Listed Building Consent Granted – Ref – 2011/4661/L

3) Installation of new louvre at lower ground floor level to South East Elevation

Full Planning Permission Granted – Ref – 2011/3969/P

Proposed Amendment

It is proposed to install louvre details to the top half of two windows. This is below the moat level on the lower ground floor. The proposed windows to have the louvre arrangement are windows LG05 & LG07 as can be seen on drawing 080228 E(0)01D.

The proposed louvres are to be powder coated steel to match the new window construction. We confirm that window G33 on elevation C is exactly what is proposed and this has already been installed as part of the works for which listed building consent has already been granted. Please see attached photograph showing window G33.
