The proposed extension projects to the same length and height as the neighbouring extension and includes a sloped roof, which mirrors the neighbouring sloped roof. Policy DP26, which is supported by CPG6 (Amenity) seeks to manage the impact of development on occupiers and neighbours and lists a number of factors that the Council will consider at planning stage including visual privacy and overlooking; overshadowing and outlook; sunlight and daylight. As the extension falls below the height of the existing single storey extension and the boundary wall and does not extend beyond the rear most elevation of the existing building, it is my view that the development would not significantly affect the amenities enjoyed by the occupiers of the neighbouring properties. Taking the above into account, it is my informal opinion that the proposed extension would be considered acceptable in principle.
