T10 requires minor deadwood removal in lower crown; G55 requires a crown clean and a crown lift to 3m to provide clearance over car park; T59 requires felling and replacing; T14a is too close to a building and requires felling.  
Full details of works required to 12 trees are detailed on schedule LEV/FYF/RTW/01, which will be sent by email. All works are advisable for good arboricultural practice.
