FRONT GARDEN, LEFT HAND SIDE OF DRIVEWAY: 3 x Lime - Raise to 4 metres above ground level. Reduce to previous points of reduction

FRONT BOUNDARY WALL: 8 x Lime - Raise to 4 metres above ground level. Reduce to previous points of reduction.

The Council has considered your application dated 21 September 2012 and decided to grant consent subject to the following condition(s):
