ENFORCEMENT NOTICE

OF Flat 5
63 Greencroft Gardens
London
NW6 3LJ

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND AFFECTED**

Land at: Flat 5, 63 Greencroft Gardens, London, NW6 3LJ

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without Planning Permission: The unauthorised installation of Upvc sash windows on the front elevation at second floor level.

4. **REASONS FOR ISSUING THIS NOTICE:**

- a) It appears to the Council that the above breach of planning control has occurred within the last **4 years**
- b) The UPVC windows by reason of their design, appearance and materials which do not reflect the design and materials of the previous windows are considered to be harmful to the character and appearance of the building as well as the South Hampstead Conservation Area and therefore are in conflict with policies CS5 and CS14 of the London Borough of Camden Core Strategy Development Plan Document and Policies DP24 and DP25 of the

Council reference: EN10/0735

London Borough of Camden Local Development Plan 2010 as well as Guidance contained within Camden's Design Guidance.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of 3 months of the Notice taking effect:

- 1) Remove the Upvc windows;
- 2) Replace the windows with timber sliding sashes which match those which previously existed.



Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications and Deemed Applications) Regulations 1989 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
