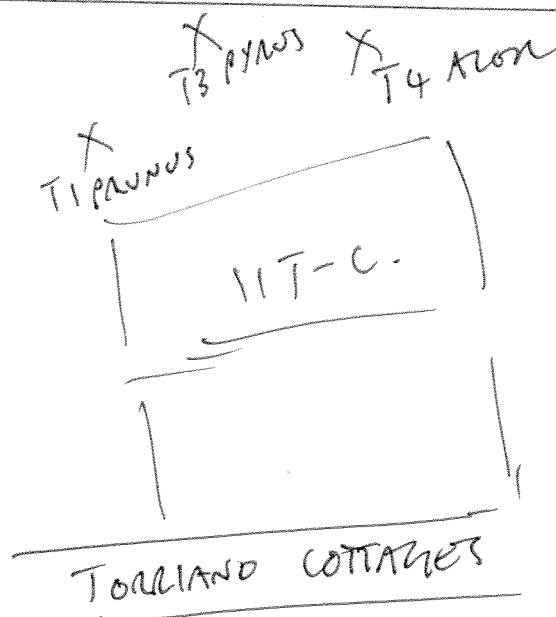

Letter sent by recorded delivery, please do not ignore this letter it is important

We are appointed by Royal and Sun Alliance to act on their behalf to resolve a problem involving damage to the property at 11 Torriano Cottages, Leighton Road, Kentish Town, London, NW5 2TA. We enclose an Arboricultural Report which our Client relies on as evidence to suggest that the damage at the property is caused by subsidence which may be made worse in the future by the potential actions of the vegetation sited within your boundary. Please note that vegetation within the boundary of your property is not implicated in the current damage but has the potential to influence the property in the future should the recommended action not be taken.

This vegetation has been identified and you will see that the report details the recommended vegetation management as:

- T1 Prunus - Future Risk – Remove and treat stump to inhibit regrowth.
- T3 Pear – Future risk – Remove and treat stump to inhibit regrowth.
- T4 Acer – Future risk – Remove and treat stump to inhibit regrowth

This letter can be produced as evidence that you were told about the risk of future damage being caused by this vegetation and advised to take the recommended action.

We are aware that your property is situated within a conservation area and as such the relevant notification will be required to the council prior to the commencement of any works. We are happy to assist with the notification to the council should you require, please contact us for further information.

If you choose not to control your vegetation as detailed within the Arboricultural Report we recommend that you advise your own Insurer as this may affect your position on liability for compensation in the future.
