Site Description							
The application site is Grade II listed former dairy within the grounds of Kenwood House. Constructed between 1794 and 1795 the dairy took a key and prominent position in the remodelling of the parkland that took place at the time. It was originally three separate buildings and remained unaltered until the early twentieth century when the London County Council converted it to residential and included link ranges behind the historic quadrant walls to connect the three building together. The site is within the Hampstead Heath Woods and is designated as a Special Site of Scientific Interest (SSSI) and Metropolitan Open Land (MOL) and a Metropolitan Site of Nature Conservation.

Assessment

1 Assessment

1.1 Planning permission and listed building consent were granted for the change of use of the existing dairy cottage from residential (Class C3) to a volunteer hub (Class D1) (see history section). As the building is listed grade II, with a roosting bat population, various conditions were attached to the planning permission and listed building consent. The applications seek to discharge these conditions, however not all of the conditions which the applicant seeks to discharge are the type of conditions that can be discharged.

2 Planning Conditions

2.1 The conditions attached to the planning permission are summarised thus:

- 1 The permission must be begun with three years
- 2 Work to be carried out in similar materials
- 3 Work to be carried out in accordance with the approved plans
- 4 A European Protected Species License to be obtained from Natural England before work commences
- 5 Biodiversity mitigation measures to be carried out in accordance with the submitted method statement
- 6 Details of bat box locations to be submitted to and approved by the Council before the building is occupied
- 7 Details of a hibernacula to be submitted to and approved by the Council before the building is occupied
- 8 Details of a lighting strategy to be submitted to and approved by the Council before the building is occupied
- 9 An up to date bat survey to be undertaken if the existing survey is more than a year old when works are scheduled to commence
- 10 Site operatives to be made aware of the presence of bats, and to stop works and inform Natural England if any bats are discovered during the works.

2.2 As such only conditions 4, 6, 7 & 8 of the planning permission can be discharged by approval of details. The applicants have indicated details relating to conditions 6, 7 & 8 will be submitted at a later date.

2.3 The applicant has submitted a copy of a European Protected Species License issued by Natural England dated 06/08/2012 in accordance with the Conservation of Habitats and Species Regulations 2010. Therefore condition 4 can be discharged.

3 Listed building conditions

- 3.1 The only dischargeable condition attached to the listed building consent is condition 3 which requires detailed drawings, or samples of materials, to be submitted to the Council for approval before the relevant part of the work is begun. The required details are:

a) Plan and elevations of proposed new housing to ice house at 1:20.

The submitted drawings show the design of a modest structure with timber and slate cladding. No objection.

b) Plan, elevation and section drawings of all new internal and external doors at a scale of 1:10 with typical moulding and architrave details at a scale of 1:1.

The submitted door drawings show a design and detailing which is appropriate to the age and style of the building.

c) Plan, elevation and section drawings of all new windows at a scale of 1:10 with typical glazing bar/leadwork details at 1:1.

The submitted window drawings show a design and detailing which is appropriate to the age and style of the building.

d) Details of paint scheme for octagonal vestibule in the south building.

The submitted paint documentation is appropriate.

e) Sample of stone paving

The applicant has indicated that a stone sample will be submitted as a separate application.

f) Plan of the ground floor showing the extent of re-plastering or dry lining to the interior.

The architect has confirmed in their covering letter that only a small amount of low level plastering is required in the team room. It was originally envisaged the extent of re-plastering would be more wide spread.

- 3.2 No objection is raised to the submitted information, although further details are required for part e of condition 3 of the listed building consent for the condition to be fully discharged.

4 Minor amendments

- 4.1 The architect has submitted drawings which show small variations from the approved scheme (such as relocation of doors to ancillary buildings). These changes are minor and do not materially alter the proposals and are considered acceptable.

5 Recommendation:
