## **TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED)**

#### **ENFORCEMENT NOTICE**

OF 42 Weavers Way Camden London NW1

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at: 42 Weavers Way, Camden, London, NW1

as shown, for the purposes of identification only, outlined in black on the attached plan.

#### 3. THE BREACH OF PLANNING CONTROL ALLEGED

**Without Planning Permission:** Erection of wooden extension to the rear of the dwelling house

#### 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years
- b) The wooden rear extension, by reason of its size, scale, proportions, materials and detailed design is detrimental to the character and appearance of the host building. It is considered contrary to policies CS14 (Promoting high quality places and conserving our heritage) and DP24 (Securing high quality design) of Camden's Local Development Framework Core Strategy and Development Policies.

c) The wooden rear extension, by reason of its size, scale, proportions is considered to have an adverse impact on the amenity of the adjoining property. It is considered contrary DP26 (Managing the impact of development on occupiers and neighbours) of Camden's Local Development Framework Core Strategy and Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

### 5. WHAT YOU ARE REQUIRED TO DO

Within six months of when the notice becomes effective:

- 1. Completely remove the unauthorised extension
- 2. Make good any damage done to the building through the removal of the extension

## 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 10 October 2012 unless an appeal is made against it beforehand.

## Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications and Deemed Applications) Regulations 1989 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.

The fee is payable both to the "Department for Communities and Local Government" for the Planning Inspectorate appeal, and also to the "London Borough of Camden", as the Local Planning Authority.

You can appeal against this notice, but any appeal must be received or posted in time to be received by the Secretary of State before 10 October 2012.


- (a) Send a copy of your appeal to the Secretary of State if you decide to appeal, together with a copy of this enforcement notice.
