Painted brickwork at rear.

New extract fans are to be fitted in 2 locations. Holes approximately 100mm in diameter will be core drilled through the walls. The exteriors of the holes will be covered by white plastic grilles.

Windows - add description

Description of *existing* materials and finishes:

Wooden sash windows at front.
Wooden fixed light and casement windows at rear.
Steel (Crittall style) casement windows at rear.

Description of *proposed* materials and finishes:

No changes externally to front or rear other than routine redecoration.
Interior of front windows to be fitted with Selectaglaze Series 20 slimline vertical sliding unit. The secondary glazing uses PPC aluminium frames and will be finished in white.
At the rear, existing glazing will be replaced with double glazed sealed units set into existing frames. The frames themselves will not be altered.
