Replacement of upper ground floor level door with window and removal of existing concrete steps; Replacement of lower ground floor level window with new access door and creation of new access stairs to the rear garden; Installation of new bathroom in rear closet wing in connection residential use (Class C3).

The development hereby permitted must be begun not later than the end of three years from the date of this permission.



Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans Site Location Plan; Drawing nos. 01, 04, 05, 06, 07, 08, 10, 11, 12 and 13 and the Design and Access Statement and Heritage Statement for 62A Fortess Road.

Reason:

For the avoidance of doubt and in the interest of proper planning.
