The site is located within the Hampstead Conservation Area, therefore the proposal's impact on the surroundings and neighbouring buildings has been assessed over the following pages.

The application site fronts onto the south side of North End.

The site itself is empty and has been cleared following the demolition of the previous dwelling on the site as part of the commencement of planning permission dated 07/02/2011 (ref: 2010/5139/P and 2010/5160/C).

The building comprised of a two storey detached dwelling dating from the 1970s with very plain elevations, uPVC windows and painted brick walls. The main roof was clad in concrete tile and a single-storey rear extension roofed with bitumen felt. The house was not identified as making a positive contribution to the character and appearance of the area.

Designated Heritage Assets

The site is within the Hampstead Conservation Area. The 2001 Hampstead Conservation Area Statement describes the area as;

"a loose cluster of quite modest houses centred on the Olde Bull and Bush pub with the Hampstead Heath Extension banked up steeply all around. It has the distinct quality of a small enclave detached from urban life. The roads peter out into paths through the surrounding woodland. Greenery dominates and the relationship between the houses, their gardens and the Heath is particularly intimate."

Adjacent to the site on the north side of North End are numerous Grade II listed buildings;

The Old Bull and Bush public house - Reputedly built as a form c1645, licensed 1721, rebuilt with modern extensions 1923-24 in similar style to the old:

I and 3 North End - Pair of early 18th century terraced houses

9 North End - Mid C19 Stucco cottage

Former coach house to Wildwood Coach house, now in domestic use. Mid C19. Stock brick

Wildwood and Lesser Wildwood - Farmhouse, now 2 residences. Mid C18. Brick

The site is also within the Hampstead Heath Archaeological Priority Area and has an article 4 direction attached to it.

The main issues to consider are the impact the erection of 4 new dwellings on the site would have on the character and appearance of the Hampstead Conservation Area and setting of the adjoining heritage assets, having particular regard to the approval for 2 x three-storey plus basement dwelling houses with forecourt parking granted permission on 07/02/2011 (ref: 2010/5139/P).

Assessment

This assessment should be read in conjunction with the full

Design and Access document.

The development has understood the significance of the Conservation Area and adjoining heritage assets. The proposal has taken the opportunity to develop 4 new dwellings which enhance the Hampstead Conservation Area within the setting of heritage assets to better relate to their setting and significance.

As well as the 'cluster of quite modest houses' on the opposite side of the road. Sub-area 8 comprises groups of terraced cottages and numerous buildings of a similar size and plot ratio. The proposal has actively responded to this prevailing pattern of development in a contemporary way so as to improve the quality of an area and give a stronger identity.

Area.

The proposal has retained the generous perimeter planting established as part of the previous scheme. This preserves the verdant and secluded character that is of importance as one enters the fringes of the heath.

As such the proposal is considered to comply with the advice set out in NPPF and with the London Borough of Camden LDF policies, design guidance and Conservation Area Statement and the London Plan. The proposal would contribute positively to the locality and improve with the character and appearance of North End as part of the Hampstead Conservation Area.

The provision of 4 dwellings on the site results in a reduction in the plot sizes and scale of each dwelling. The more modest scale dwellings directly respond to the development and finer grain of the historic terraced dwellings on the opposite side of North End over above the extant scheme.

This reinforces the elements of the immediate area which create the distinct character and thereby enhances the setting and special interest of the listed buildings

In this regard the scale, form and vernacular design of the dwellings enhance the character of Hampstead Conservation

Formerly known as: The Hill North End Way Substantial house, now a convalescent home. Original house 1807, rebuilt c 1895 and successfully modified by WH Lever, Viscount Leverhulme, who owned the house from 1904 until his death in 1925. Alterations included rebuilding of central block and addition of north and south wings to garden front (now with C20 2nd storeys) of c1905 by Grayson and Ould of Liverpool who also design the terrace along the garden front to which Thomas H Mawson added iconic veranda c1910.

Formal pond surround, fountain and pedestals on a wide terrace, aligned westwards on Inverforth House, running east-west from Terrace Steps to Cruciform Pergola. C 1906-10. By Thomas H Mawson as part of a garden scheme for Lord Leverhulme at the Hill (now Inverforth House). Paved stone surround tor rectangular pond with curved ends and central fountain, at 1978 listing with bronze statue of boy on a dolphin, now missing. Pond flanked by pedestals which at 1978 listing supposed Classical urns, now missing. Historical Note: the garden was divided when the house became a hospital: for the remainder of the garden see under The Hill Garden, North End Way.

Terrace later altered 1926 by Leslie Mansfield whi added a ballroom beneath it. South wing extended and remodelled 1924-5 by Mawson in conjunction with TH Mawson and Sons: library wing added entrance front 1913-14 by William and Segar Owen of Warrington. Red brick; steeply pitched, hipped tiled roof to eaves. Neo-Georgian manner with Queen Anne style wings to garden front.

Exterior: 2 storeys plus roof storey and basement. North and south wings formerly single storey. Garden front unified horizontally by a Portland stone ionic colonnade across the ground floor, with three segmental projections and balustrading to terrace. Dominant slightly projecting centre piece of 5 bays beneath hipped roof with open segmental pediment to central dormer. Canted bay window to 1st floor centre bay of 3 windows wide, flanked by smaller canted timber bay windows; 4 further windows to wings on either side/ Flush frames with small panes, some with transoms and mullions. Stone eaves cornice. Projecting wings have brick half-columns applied between bays, the 3 bays closest to house being treated as an arcade with arches between piers; remaining bays with brick architraves to 18-paned sashes. Much rubbed brickwork: rich moulded brick cornices.

Interiors: richly decorated in various styles ranging from Jacobean to William and Mary Adamesque. Decorative features of interest throughout the house but of particular note are the ionic pilastered entrance hall with carved marble staircase, the fine Adam-style room opening onto the terrace at ground floor level with its columnar screen and decorative plasterwork ceiling and cornice; also the marble columned lobby to the south of this at ground floor level and the music room panelled in C17 style and probably reusing some C17 woodwork, particularly in the decorative chimney-piece. A non architectural amalgam reflecting the tastes of a notable patron.

Historical Note: following Leverhulme's death in 1925, the house was bought by Lord Inverforth and when he dies The Hill was presented to Manor House Hospital in 1956. The gardens were designed and laid out by Thomas H Mawson from 1905. Further northern garden laid out during 1920s by Leslie Mansfield. Garden west of the Formal Pond and further northern garden, now under separate ownership and known as The Hill Garden, north end Way; this garden is open to the public.
