We have a conifer tree that is growing very close to the side wall of our property by our entrance (roughly situated in the middle of our property - between the street side and the garden side).

Our building surveyor has told us that the conifer should be removed if possible so as not to cause further damage to our building and its foundations. We are therefore please asking for permission to remove the conifer and plant another conifer in the back of the garden where it will have more room to grow and be enjoyed by the residents.
