### **Assessment**

### Proposal:

Permission is sought for an amendment a previously approved scheme (see planning history above) to install a temporary information kiosk in association with the 2012 Olympics.

#### Assessment:

The proposed Kiosk would be slightly smaller than the approved, but would retain a very similar appearance. The proposed kiosk would measure 1.92m x 3m at its base with a maximum height of 3.1m (the approved would be 3.7m).

The proposal is considered to be acceptable in terms of appearance and location. It would be located so as not to have a detrimental impact on pedestrian flow. Given that the overall dimensions and appearance are similar to the approved it is not considered that the proposed is materially different.

It is not considered that the proposal would harm the character or appearance of Euston Station and the plaza and would comply with policies CS14, DP24 and DP25 of the Local Development Framework and Camden Planning Guidance.

Recommendation: Grant non-material amendment.
