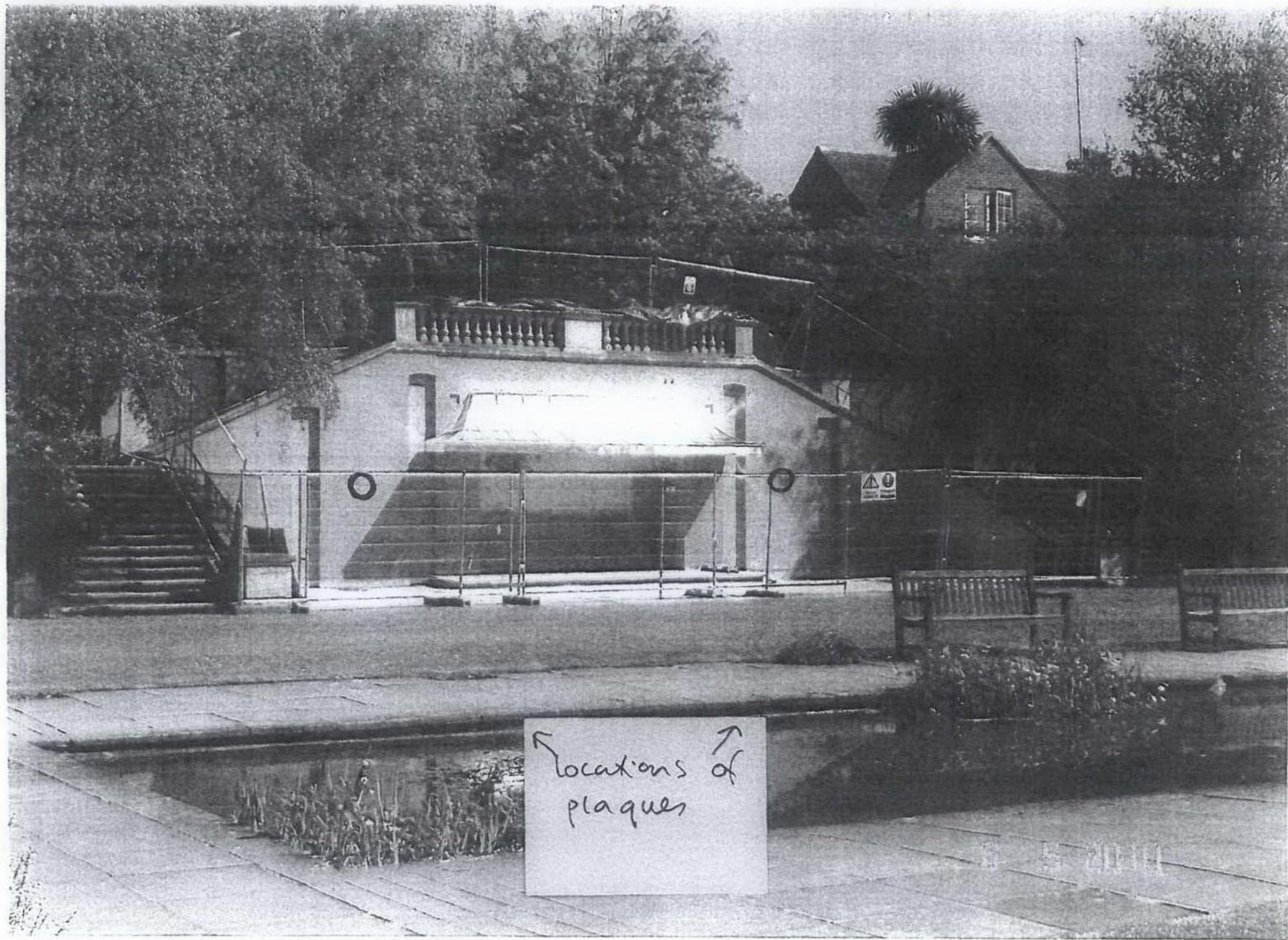

This shelter was built by Lord

court which was located where the
pond, built by the London County
Council in 1963, now stands.
