LISTED BUILDING ENFORCEMENT NOTICE - EN07/0196

OF 55 Albert Street London NW1 7LX

1. **THIS IS A FORMAL NOTICE**, which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

2. THE LISTED BUILDING.

Land at: 55 Albert Street, London, NW1 7LX

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE CONTRAVENTION ALLEGED.

Without listed building consent: Unauthorised installation of uPVC frame affixed externally from the original windows to front elevation at 1st floor level.

4. REASONS FOR ISSUING THIS NOTICE

- a) The work outlined above has been carried out to this **Grade II listed building** without the benefit of Listed Building Consent
- b) The unauthorised uPVC window frames by virtue of their design and materials are harmful to the special architectural and historic interest of the listed building, therefore contrary to London Borough of Camden Local Development Framework 2010 Core Strategy policy CS14 Promoting high quality places and conserving our heritage and development policies DP24 Securing High Quality Design and DP25 Conserving Camden's heritage.

5. WHAT YOU ARE REQUIRED TO DO

The Notice shall require that within a period of 3 months of the Notice taking effect;

1) The removal of the unauthorised uPVC window frames affixed externally from the original windows to front elevation at 1st floor level.

2) Make good any damage to the listed building.

Compliance due date: 10 December 2012

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **10 September 2012**, unless an appeal is made against it beforehand.



Failure to comply with a listed building enforcement notice, which has taken effect, can result in prosecution and/or remedial action by the Council.
