# TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED)

### **ENFORCEMENT NOTICE - EN10/0405**

OF 4 Ferdinand Street London NW1 8ER

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information

#### 2. THE LAND AFFECTED

Land at: 4 Ferdinand Street, London, NW1 8ER

as shown, for the purposes of identification only, outlined in black on the attached plan.

# 3. THE BREACH OF PLANNING CONTROL ALLEGED

**Without Planning Permission:** The unauthorised use of the property as a bar/restaurant.

### 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 10 years.
- b) The bar/restaurant, by reason of the location in a predominately residential area has a harmful impact on the amenity of residents and the local area contrary to policies CS1 (Distribution of Growth), CS5 (Managing the impact of growth and development), CS7 (Promoting Camden's centres and shops), policy DP12 (Supporting strong centres and managing the impact of food, drink, entertainment and other town centre uses) and DP26 (Managing

the impact of development on occupiers and neighbours) of the London Borough of Camden Local Development Framework.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

## 5. WHAT YOU ARE REQUIRED TO DO

# Within a period of 3 months from the notice taking effect:

The use of the premises as restaurant and bar shall cease and any associated fixtures and fittings shall be removed.

Compliance due date: 10 December 2012

## 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 10 September 2012 unless an appeal is made against it beforehand.

# Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications and Deemed Applications) Regulations 1989 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.

The fee is payable both to the "Department for Communities and Local Government" for the Planning Inspectorate appeal, and also to the "London Borough of Camden", as the Local Planning Authority.

# ANNEX YOUR RIGHT OF APPEAL


You can appeal against this notice, but any appeal must be received or posted in time to be received by the Secretary of State before 10 September 2012.

# WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on 10 September 2012, and you must then ensure that the required steps for complying with it, for which you may held responsible, are taken within the period specified in the notice. Failure to comply with an enforcement notice, which has taken effect, can result in prosecution and/or remedial action by the Council.
