## Assessment

### Proposal

Permission is sought a floor decal which will be located on the pavement outside the Grafton Way entrance to the building. The advert would be for a temporary period of time prior, during and after the Olympic and Para-Olympic games until the 30<sup>th</sup> September 2012.

The floor decal will depict a visual of an athlete and would be 3 metres x 3 metres.

The Town and Country Planning (Control of Advertisements) Regulations 2007 permits the Council to only consider amenity and public safety matters in determining advertisement consent applications.

**Design:** The advertisement would be visible from the public realm and would be of substantial size. However, the advert would only be in place for a temporary period up until the 30<sup>th</sup> September, and the advertisement is for an event of national significance, due to these reasons it is considered as an exception that the proposed advertisements would be acceptable in design terms.

**Public Safety:** Owing to its location the proposed decal would not be harmful to pedestrian or vehicle traffic nor would hinder the interpretation of road traffic signs or distract motorists.

### Recommendation:

The proposed advert is in general compliance with policies CS14, DP24 and DP25 of the Local Development Framework the application is therefore recommended for approval.
